Via Metro: Takoma Metro Station on the Red line. Walk 1 block east (toward downtown Takoma Park, MD) to Maple Street, NW. Turn left, walk 2.5 long blocks along Maple (Street becomes Avenue over the Maryland line) to Philadelphia Avenue (Route 410).

Via car: Go to the corner of Piney Branch Road (Route 320) and Philadelphia Avenue (Route 410). Turn east, toward downtown Takoma Park, MD. Go 3.5 blocks. Turn left into the parking lot of Takoma Park Municipal Center.
